BC Home Birth Data Collection:

A Six-Month Review

On April 1, 2016, home birth data collection transferred to each health authority under the BC Home Birth Supplies Program.

Since this transition, PSBC has successfully received home birth data collected by designated coding sites.

We thank the coders for their diligence in abstracting high quality data.

With all things new, there are early bumps along the road, but we hope to iron these out. From questions we have received from coders and upon review of the data, PSBC has developed clarifications in this issue to accompany data quality checks to improve the data.

Data Quality For Home Birth Records

In early 2017, home birth data quality reports will be forwarded to designated home birth coding sites for corrections. To provide clarity and to facilitate data correction, the following table summarizes specific data fields and common data errors. After saving and validating all your corrections, these records will be automatically submitted in the next period end process.
