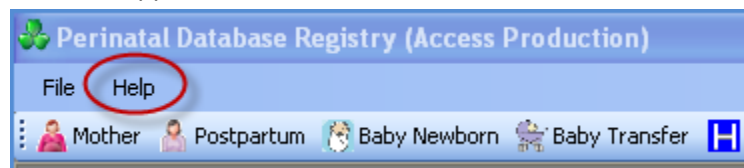
Resource Page for Coders

Perinatal Services BC (PSBC) has launched a new page on the [PSBC website](#). This page is exclusively for Health Information Management Professionals (HIM) using the Perinatal Database. This is the initial release of our resource page, and we hope that you will find it practical and useful in your work with the PDR. We will be updating this page frequently, so please visit on a regular basis. Please also feel free to provide us with feedback.

PDR Reference Manual

Please note: The electronic PDR Help function, which is part of the Perinatal Database application, is outdated and should not be used.



PDR Data Quality Tool (DQ Tool)

PSBC revised the DQ Tool in January 2013. These changes were primarily based on your feedback and the recent CIHI code changes. A total of approximately 20 edits were eliminated and 36 were modified. No new edits were added to the Tool. Over the next few weeks, PSBC will be disseminating the Tool to all facilities requesting this feature.

Clarification of PDR Scope

Due to some confusion regarding the criteria for data collection in the Perinatal Database, the following clarification has been provided for your convenience. Please contact psbc@phsa.ca if you have any questions.

DELIVERY MOTHER: If a mother is admitted to a BC hospital and delivers a newborn or stillborn, enter this mother in the Delivery Suite. If a mother is admitted *within 24 hours* post delivery from home or *within 24 hours* after delivering en route to hospital, enter this mother in the Delivery Suite.

POSTPARTUM MOTHER: If a mother is admitted *within 42 days post delivery* as an inpatient or surgical day care patient, enter this mother in the Postpartum Suite.

NEWBORN: If a baby is born in a BC hospital or admitted to a BC Hospital *within 24 hours post* delivery from home or en route to hospital, enter this baby in the Newborn Suite. All stillborns are entered in the Newborn Suite, regardless of the location of birth (hospital, home, en route). If the mother of the stillborn is not admitted to hospital, the stillborn will be unlinked.

TRANSFER READMISSION: If a newborn is admitted to hospital *within 28 days post discharge to home*, enter this baby in the Baby Transfer/Readmission suite. This includes companion well babies. If a baby is transferred to a BC hospital and is *never* discharged home during this time, enter the baby in the Transfer/Readmission suite until one year of age.

NICU Daily Classification

The NICU Daily Classification Monthly Record is a form that is used to collect information on babies in the NICU according to their needs. It is collected on a daily basis. At this time, only NICU sites are required to collect this information. Collection at non-NICU sites has yet to be determined.
